## Preface

**Kalinga Institute of Social Sciences (KISS)**, Bhubaneswar, Odisha, India, was established in the year 1993 with only 125 poor tribal children in a residential model School at Bhubaneswar. Now, it is the largest Fully Free Fully Residential Educational Institution for more than **60,000 (30,000 Existing, 20,000 Alumni and 10,000 at Satellite Centres)** poorest of the poor indigenous children & youth in the world, providing holistic education from **Class-I to Ph.D.** along with free lodging, boarding and health care facilities. Besides, KISS is imparting vocational training, life skills education and exposure to sports & athletics in both national and international level. KISS has received the Special Consultative Status by the **United Nations Economic and Social Council (UN-ECOSOC) in the year 2015**. The students of KISS qualified and took admission in premiere institutes of international repute, and they have also participated and achieved success in Olympics, ASIAD, Common Wealth, South Asian Federation Games and many other prestigious sports events at national and international level. KISS has expanded its initiatives to educate more numbers of indigenous children by replicating the same model in different states of the country.

In view of the outstanding contributions of KISS towards academics in the field of teaching-learning, research, extension activities, sports and games, it has been recognized and declared as a **Deemed to be University U/S 3 of the UGC Act, 1956** by the Ministry of Human Resource Development, Govt of India, New Delhi on the basis of the recommendation of the **University Grants Commission, (UGC) New Delhi**: vide notification No F.9-14/2011-U.3 (A) dated 25th August 2017. It became the First University in the World exclusively for the tribal students providing fully free and fully residential education along with other facilities. Accordingly, the University has been functioning since the afore-mentioned date with all its P.G. and Ph.D. Programmes. KISS Deemed to be University has been admitting students from within and outside the states, i.e., Jharkhand, Assam, Mizoram, West-Bengal, Chhattisgarh etc. KISS Deemed to be University aims at taking further the academics to newer heights and focusing on teaching and research in 'Unique and Emerging areas of Knowledge' related to specific innovative areas, namely Tribal Culture, Philosophy and Eco-spiritualism, Tribal Heritage and Tribal Indology, Comparative Tribal Languages and Literatures, Indigenous Knowledge, Science and Technology, Comparative Indic Studies and Tribal Science,



Tribal Resource Management, Tribal Legal Studies and Tribal Rights, which are not being offered at any other Institution in the World.

- ❖ To prioritize the admission of the meritorious tribal girls.
- ❖ To promote admission of extraordinary sports achievers.
- ❖ To bring transparency to the admission process.



- ❖ To enable study and research on various aspects of tribal culture, literature, languages, rights, sciences and resource management.
- ❖ To broaden the placement avenues of all the pass out students.
- ❖ To ensure earning while learning under the “Earn While You Learn” scheme of the University.

## Guidelines

- ❖ As the largest fully residential and fully free educational institute for the tribal (Indigenous people), KISS is committed to providing free accommodation, food, healthcare and education to tribal students from families in the Below Poverty Line (BPL) category only.
- ❖ KISS gives special emphasis to women’s education, thereby giving preference to girl students during admission.
- ❖ ST students belonging to Particularly Vulnerable Tribal Groups (PVTGs) are also given preference during the admission process.
- ❖ The admission forms for admission of students [for P.G., and Ph.D. are available on the KISS website [<https://university.kiss.ac.in>] as per notification.
- ❖ Online procedures for submission of the application will be available on the website.

*N.B- There is a common online application form for admission into P.G/Ph.D. programmes.*

## Admission into Post Graduation Courses

Admission into P.G. will be channelled into different Schools under Arts, Science and Commerce streams. All programmes will focus on different aspects of tribal studies such as: Culture, Philosophy, Heritage, Science & Technology, Languages & Literatures, Resource Management, Legal Studies and Rights.

### General Eligibility Criteria

- A. Candidate should have passed Three-year Degree Examination in Arts/Science/Commerce/Law (B.A./B.Sc./B.Com./LL.B.), or any equivalent examination from a UGC recognized University. He or

she is required to obtain Honours in the concerned subject or at least 45% in aggregate in the same examination where the said subject is a “Pass” subject.

- B. Candidates, who have appeared at the qualifying examinations and the results thereof are awaited, may be eligible to apply. However, they have to submit the Provisional Certificate and Mark sheet of the qualifying examination within ten days after the publication of result, or on the date of entrance test whichever is later. Otherwise, their cases for selection shall not be considered.
- C. A candidate, who already possesses a P.G. Degree, shall not be eligible to take admission in the same or any other P.G. Degree / P.G. Diploma / Certificate Courses in the University.

### Eligibility for Specific Courses

Apart from the general eligibility criteria, admission to P.G. programmes within the seven departments will be as follows:

1. **School of Tribal Culture, Philosophy and Eco-Spiritualism (STCPE):** ST students having Honours or Pass in Political Science, Philosophy and History at UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Arts subject at UG level are also eligible to apply.
2. **School of Tribal Heritage and Tribal Indology (STHTI):** ST students having Honours or Pass in Education, Home Science, Psychology at UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Arts subject at UG level are also eligible to apply.
3. **School of Comparative Tribal Languages and Literatures (SCTLL):** ST students having Honours or Pass in English, Odia, Sanskrit and Hindi UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Arts subject at UG level are also eligible to apply.
4. **School of Tribal Legal Studies and Tribal Rights (STLSTR):** ST students having Honours or Pass in Anthropology, Sociology and Social Work at UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Arts subject at UG level are also eligible to apply.



5. **School of Indigenous Knowledge Science and Technology (SIKST):** ST students having Honours or Pass in Chemistry, Physics, Mathematics and Computer Science at UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Science subject at UG level are also eligible to apply.
6. **School of Comparative Indic Studies and Tribal Science (SCIISTS):** ST students having Honours or Pass in Botany, Zoology, Food Science and Technology and Biotechnology at UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Science subject at UG level are also eligible to apply.
7. **School of Tribal Resource Management (STRM):** ST students having Honours or Pass in Commerce, Economics and Geography at UG level will be given preference for admission in this School. However, students having Honours or Pass in any other Arts/Commerce subject at UG level are also eligible to apply.

## Online Admission

- (i) Online filling up of application form shall begin as per notification from the University.
- (ii) The applicant must submit the application form online before the last day of submission.
- (iii) Visit <https://university.kiss.ac.in> and click “Admission” on Quick links for admission link.
- (iv) The candidates should read the Prospectus carefully before filling up of the forms online.

The candidates can then fill-up the forms online. After completion of all the fields in the form, the candidates should click the “submit” button. Thereafter a page will be opened with all the information of the candidate that he/she has filled in. The candidate then has to take a printout of this page and send/submit it along with the following documents when he/she will be shortlisted for verification.

- a) Two recent passport size colour photographs of the candidate.
- b) Self-attested copies of the Mark sheets and Certificates of all examinations starting from H.S.C for determining eligibility.

- c) A self-attested copy of the e-Caste, e-income and e-residence certificate in original and photocopy obtained from government, in absence of which the candidate will not be eligible.
- d) An attested copy of the certificate from CDMO regarding his/her disability for 50% or more (in case of Physically Handicapped Candidates).
- e) Photocopy of Aadhaar card and ration card
- f) The undertaking form(s) should be duly filled in and signed by the applicant and his/her father or natural guardian. The envelope containing the application complete in all respect must be superscribed **“Application for Admission in the P.G. Department of \_\_\_\_\_” KISS Deemed to be University.**
- g) Application incomplete in any manner shall be rejected.

### Procedure for downloading the Admit Card

Admit Card will be available on the website for eligible candidates. Candidates should login and download the same.

Selection Procedure:

- (i) Admission cannot be claimed as a matter of right.
- (ii) Absence of a candidate in the written test shall disqualify him/her for admission.
- (iii) Selection for admission into different Courses shall be done through Written Entrance Test (with coding and decoding system) and Career Mark with 50% and 50% weightage, respectively.
- (iv) The written test will cover Honours syllabi of the subject in the qualifying examination of the University.
- (v) Reservation for Physically Handicapped (PH) applicants with 40% and above disability shall be 5% of the total seats. The reservation is applied subject wise in each Programme. However, any subsequent modification in the reservation policy as per the Government of Odisha notification will be notified accordingly.
- (vi) 5% of the total career mark secured by the candidate in qualifying examination shall be added to the career mark in qualifying examination to a maximum of 15 in case of participants in the Inter University Sports and State Team approved by the National Organization provided that in order to be eligible for such



concession under sportsman category the player concerned should have participated in the respective competitions within two years prior to the date of application for admission.

- (vii) NCC-Applicants holding B Certificate shall be given weightage of additional 5% of marks over and above the aggregate marks secured at the Higher Secondary (+2) or equivalent examination.

Applicants who have represented the State or the Central School / Sainik School at the All-India level NCC Camps / Courses / Activities shall be given weightage of additional 3% of marks over and above the aggregate marks secured at the Higher Secondary (+2) or equivalent examinations.

- (viii) NSS-Applicants who have represented the state at National Level Camp shall be given weightage of additional 5% of marks over and above the aggregate marks secured at the CHSE / equivalent examinations.

Applicants who have represented the Inter State Category Camp shall be given weightage of additional 3% of marks over and above the aggregate marks secured at the CHSE / equivalent examinations.

Applicants who have got the best NSS Volunteer Award in University level shall be given weightage of additional 2% of marks over and above the aggregate marks secured in CHSE / equivalent examinations.

- (ix) Rover & Ranger-Rover & Ranger possessing and producing the original certificate signed by the President of India shall be given weightage of additional 5% of marks over and above the aggregate marks secured at the Higher Secondary (+2) / equivalent examinations.

Rover & Ranger possessing and producing the original certificate signed by the Governor / PATRON / President of the State Association shall be given weightage of additional 2% of marks over and above the aggregate marks secured at the Higher Secondary (+2) / equivalent examinations.

## Selection will be made on the basis of merit determined as per the following criteria:

Admission into the P.G. courses shall be on the basis of 50% Career and 50% Entrance Test.

**Written Test for admission shall not be conducted where the numbers of applicants are less than the sanctioned strength. In that case only eligibility criteria shall be considered.**

**Admission into any P.G. Course is Provisional.** A candidate, once selected for provisional admission, will have to produce his/ her final mark sheet and CLC/ TC/ Migration Certificate (as provided by the institution last attended) on the date of admission to prove his/her eligibility, failing which he/she shall not be considered for admission.



## Publication of Merit List and Admission Dates

The first merit list, along with the admission / counselling dates of provisionally selected candidates, will be notified on the notice boards of the university within 15 days tentatively of the completion of entrance test of all subjects. Candidates are required to keep a watch on the university website regarding the merit list and counselling / admission dates and appear for the same as per the schedule, with required documents. All merit lists will be published in the notice boards of the university only.

**\*NO SEPARATE INTIMATION SHALL BE ISSUED TO THE CANDIDATES FOR ATTENDING COUNSELLING/ ADMISSION.**

The provisionally selected candidates (List to be published in the university Notice Board) will be required to take admission on the scheduled date of admission. Under no circumstances extension of date of admission shall be allowed. However, 'five working days' time will be given to the candidates for the submission of transfer certificate/any other document required for admission. The candidate is required to submit an undertaking in this regard. No further claim for admission will be entertained after the expiry period.

The management reserves the right to select or reject the candidature of any applicants without showing any reason thereof.

## Guidelines for KISS Entrance Examination (KISSEE)

- a. Qualifying the entrance test shall not, ipso facto, entitle a candidate to get enrolment in the Programme concerned where he/she intends to seek admission. It will be the responsibility of the candidate to ensure his/her eligibility and fulfilment of such other conditions as may be prescribed for admission in the rules and regulations of the university.
- b. Any visually challenged candidate can avail himself/herself of the services of a writer during the Entrance Test.
- c. Admit cards will be issued to the candidates provisionally. The candidates shall be taking the test at their own risk and responsibility, subject to final confirmation of their eligibility at the time of enrolment. The university shall, in no way, be responsible if they are found to be ineligible later, leading to cancellation of their result or any other consequence(s) emanating from the same.
- d. **PATTERN OF QUESTIONS IN ENTRANCE TEST FOR P.G. COURSES**

- There shall be questions of 50 marks and all questions are compulsory.
  - No mark will be deducted for wrong response.
  - Each paper will be of 90-minutes duration with 50 multiple choice questions. Of these, 30 questions will be set from Honours /Core papers, and 20 questions from English and General Knowledge.
- e. No candidate shall be allowed to take the entrance test without the admit card under any circumstances. The candidates must retain the admit card with them till the admission process is over, and must produce the same at the time of enrolment.
- f. The candidates need to show the original certificates, mark sheets and other necessary documents at the time of document verification during admission. The admission shall be cancelled at any point of time if the certificates / mark sheets/ any other documents are found to be forged / manipulated.

### **Documents to be Produced at the Time of Counselling/ Admission**

- Print out of the application form (printed application form after online submission) with a recent passport size photograph affixed on it.
- Certificate of High School Examination or equivalent in support of age.
- Mark Sheet and Certificate of Higher Secondary Examination or equivalent, UG examination.
- School or College Leaving Certificate.
- Migration Certificate, if any.
- Recent e-Caste (only STs), Income and Resident Certificates.
- BPL Card/ Ration Card of Parents.
- 5 nos. of recent Stamp and Passport size photographs.
- Aadhaar Card.
- The photocopies of all documents should be signed by the candidate as proof of self-attestation is to be submitted. Submission of incorrect



information with intention to defraud may lead to cancellation of admission, and make a candidate liable for criminal proceedings.

## Admission into Ph.D. Programmes

### Ph.D. Programmes

The basic objective of the KISS Deemed to be University is to do research on innovative areas of knowledge particularly the Tribal Culture, Philosophy, Art & Crafts, Medicinal Systems, Indology, Heritage, Customary Law, Tribal Resources, Tribal Languages & Literatures etc. Keeping all these in view, KISS Deemed to be University has started research programmes leading to Ph.D. degree.

Admission process of Ph.D. Programmes shall govern the conduct of research and examination of thesis leading to the award of the degree of “Doctor of Philosophy (Ph.D.)” of the Kalinga Institute of Social Sciences KISS, Deemed to be University. KISS-DU has been working in the innovative areas of knowledge particularly interdisciplinary and multidisciplinary subjects with special reference to Tribal Culture, Philosophy, Art & Crafts, Medicinal Systems, Indology, Heritage, Customary Law, Tribal Resources, Tribal Languages & Literatures etc. It will be guaranteed by Ph. D. Regulation of KISS Deemed to be University and (to be revised from time to times as per UGC Guidelines and Minimum Standards and Procedure for Award of Ph.D. Degrees) Regulations of UGC.

In Ph.D. programmes there will be one semester pre-Ph.D Course work which include four papers, namely, research methods, computer application, subject specific and review of literature. After successful completion of the course work and subject to availability of Ph.D. supervisors, the students will be allowed to take research work leading to writing thesis followed by viva voce.

### Objectives

The students will be required to:

- ❖ Reflect on the basic parameters like the learner, the teacher, the teaching-learning process, the school context, the larger societal context, the support systems and various connections and

interconnections between these parameters of interdisciplinary research.

- ❖ Appreciate that research would help to enhance efficiency, effectiveness, quality and excellence in the system.
- ❖ Develop an analytical understanding about problems of the society and to explore alternative solutions.
- ❖ Develop competency in undertaking leadership in the areas of social sciences in teaching in the new frontiers of research.
- ❖ Develop a rational conceptualization of interdisciplinary research and recent new knowledge.
- ❖ Develop competency in undertaking independent micro and macro level research projects in the emerging areas knowledge by adopting interdisciplinary and multidisciplinary research.

**Outcome:** On completion of the programme, students will be able to:

- Demonstrate critical understanding, at an advanced level, of up-to-date knowledge and research methodology of a particular field.
- Implement effective academic and personal strategies for carrying out research projects independently and ethically.
- Contribute original knowledge in response to issues in their specialized area.
- Communicate research findings at a diverse range of levels and through a variety of media.
- Evaluate one's own research in relation to important and latest issues in the field.
- Engage in critical intellectual enquiry, critically evaluate information and ideas from multiple perspectives, integrate knowledge at the forefront of a particular field.
- Demonstrate a thorough understanding of research methodologies and techniques at an advanced level, develop, design and implement research projects competently and independently, conduct innovative, high-impact and leading edge research, engage in original research that takes a new technological, methodological, or theoretical approach.



- Provide novel solutions to complex problems, Identify and define emerging problems, Offer innovative and original solutions to problems and issues in novel situations.
- Demonstrate adherence to personal and professional ethics, Maintain the highest standards of personal and academic integrity, Understand complex ethical and professional issues.
- Demonstrate leadership and advocacy skills, Articulate analyses and propose solutions in response to social issues.
- Communicate and disseminate research findings effectively in the academic community and share the same with the stakeholders in society, work with others and make constructive contributions, engage in intellectual exchange with researchers from other disciplines to address important research issues, collaborate effectively with researchers from different cultures.
- Monitor, review and reflect on one's own work and competencies, and change and adapt in the light of new demands, evaluate contribution of one's own work to the field Demonstrate flexibility to accommodate new knowledge and perspectives.

### Eligibility for Admission

1. Candidates for admission to the Ph.D. programme shall have a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution.
2. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to differently-abled categories of candidates as per the decision of the Commission from time to time, or for those who had obtained their Master's degree prior to 19th September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

3. The application form, available 'ONLINE' as well as obtainable from the Admission Section of the University, must be submitted along with the documents. Details are, however, available in the Information Brochure in the University website <https://university.kiss.ac.in>
4. Selection of a research scholar shall be based on the academic career and the performance of the candidate in the Entrance Test and Interview at the University.
5. Candidates, qualified in any one or more National Level Examinations such as NET, JRF, Lectureship or equivalent, may be exempted from appearing in the Entrance Test of the University.
6. Candidates having M.Phil. or equivalent degree are also exempted from appearing in the Entrance Test of the University provided they have been admitted through a written entrance test.
7. Candidates exempted from appearing in the Entrance Test of the University will have to, however, face the Interview at the University.

### Admission Procedure

- ❖ Candidates seeking admission to the course through the Entrance Test shall be selected on the basis of their performance both in the Entrance test followed by a personal interview, which shall be conducted in the beginning of academic session.
- ❖ There shall be one paper for the Entrance test. The paper will have subjective type questions.
- ❖ A candidate has to secure a minimum of 50% marks in the paper of the Entrance test for becoming eligible to appear at the personal interview.
- ❖ No scrutiny/re-evaluation of the answer books of the written test shall be allowed.
- ❖ The applicants who have qualified the UGC-NET/CSIR-JRF or similar tests conducted by other national agencies will be exempted from appearing at the Ph.D. Entrance test, provided the period of their UGC-NET/CSIR-JRF is valid on the due date of admission in the course. Such applicants will be directly called for a personal interview.
- ❖ The personal interview will carry 50% weightage.



- ❖ All the Professors, faculty members two each from Associate Professors and Assistant Professor on the basis of their seniority from the concerned Department/School will constitute the board. The interview board will comprise of only eligible supervisors. The minimum number of members on the board shall be three. Otherwise, members from the concerned department on the basis of their seniority shall be nominated by the Dean of the concerned school. The Head/Director of the Department/Institute in the rank of Professor/ Associate Professor will act as the Chairman of the Interview Board. Otherwise, the Dean of the faculty will act as the Chairman.
- ❖ The Examination Cell of the University and the personal interview by the concerned Department/School will conduct the Entrance test and personal interview respectively. The examination branch will send a list of qualified candidates to the concerned department only without mentioning their secured marks.
- ❖ The merit list of the candidates seeking admission through entrance test will be prepared by the Examination Cell on the basis of total marks secured both in the Entrance test and personal interview whereas for UGC-NET/CSIR-JRF qualified applicants it will be on only the basis of marks secured in the personal interview. The Controller of Examination will declare the result on receipt of the marks secured by candidates in the personal interview.

## Discipline & Ragging Rules

Boarders are expected to maintain discipline and proper atmosphere of studies inside /outside the campus and the hostels.

The following acts of indiscipline are strictly prohibited:

- All kinds of shouting, violence, knocking or /and any other act of undesirable behaviour that is likely to cause disturbance or annoyance to others.
- Ragging of all kinds in the hostels or in the class rooms and within or outside the Campus.
- Any form of playing music and video system inside the room or the hostel premises.
- Maltreating or abusing the hostel employees, mess canteen staff and others.
- Any meeting not relating to hostel affairs held on the hostel premises without prior permission.
- Keeping fire arms, weapons and intoxicants of any kind in the hostels.
- Cooking in the room of the hostels.
- The use of electric heaters, immersion heater, and other similar electrical appliances in the room.
- Keeping the light and fan on when boarders are not inside the rooms.
- Damaging, misusing and stealing of any hostel property or stealing others belongings.
- Boarders staying outside overnight without permission of the competent authority.
- Overstaying in Hostels by the boarders without permission of competent authority.
- Entertaining guest/outsideers in the hostel without written permission of the respective Hostel Superintendent.
- Leaving KISS-DU campus without intimating the hostel authority in writing and without taking prior permission.
- Consumption of alcohol and / or any other intoxicant by a boarder.
- Sexual harassment of any kind.
- Sexist or Casteist remark of any kind.



## **Penalty & Punishment to the Students Indulging in Ragging inside the University/Department/Hostel premises.**

- (i) As per Supreme Court order communicated to University by the University Grants Commission, New Delhi, ragging in any form is strictly prohibited. If any incident of ragging comes to the notice of the authority the accused student will be given an opportunity to explain, and if his/her explanation is not satisfactory, the authority would expel him/her from the institution as well as hostel if he/she is a boarder.
- (ii) While admitting the students each H.O.D. shall ensure the submission of an undertaking in the format prescribed in the admission application form signed by both the candidate and his/her parents (or legal guardian).

## **General Discipline**

The students are expected to maintain discipline and proper atmosphere of study in the university campus.

The following acts of indiscipline are strictly prohibited:

- a) Any act of preventing the teaching and non-teaching staff of the university from discharging their normal duties.

- d) Any act of assembling in a meeting or going in a procession inside the university campus without prior notice to the authority or without availing the usual channels of grievance redressal.
- e) Any other agitational activity that will affect the day-to-day running of the university system.
- f) Sexual harassment of any kind.
- g) Sexist or Casteist remark of any kind.
