

#### I. DEFINITION

Unless the context otherwise requires, expressions defined below shall have meaning so defined in the Memorandum of Association and the Rules and Regulations of the KSA.

- "The Association" means the KISS Alumni Association An association of former students of KISS for advocating Education & Empowerment of vulnerable tribal children.
- "The General Body" means the General Body of the KAA. b) "The Management" means the Board of Management of the KASA with c)

There shall be three classes of Members of the Association.

### **Founding Members:**

Those who took an active interest in the functioning of the Association by subscribing their names at the time of registration and were enrolled in the roll of Members as Founding Member.

## **Ordinary Members:**

Ordinary Members are those persons who share the objects of the Association and are admitted by the Executive Body as Members. They have to sign the roll of Members of the Association so as to be treated as Members.

### **Special Members:**

Those who took an active role in guiding the functioning of the Association and are admitted by the Executive Body as Special Members.

## II. GENERAL BODY:

The General Body of KAA shall be composed of the Founding Members; the Ordinary Members & Special Members. Those who have signed the roll of Members and have not ceased to be Members one month before the General Body can attend the General Body Meeting and have power of Voting.

# III. RIGHTS AND DUTIES OF THE MEMBERS:

The Members admitted under different categories will be entitled to the facilities offered by KISS, besides having the right to vote at the meeting of the General Body;

The members can resign in writing which will be effective after acceptance by the Board of Management;

Any member who has committed a breach of any of the Rules of the KAA or who has refused or neglected to abide by any of such Rules or who has committed any act which in the opinion of the Board of Management is likely to bring discredit to the Association and KISS may be removed from the membership by a Resolution of three-fourth of the Members of the Board of Management, after hearing the member.

# V. FUNCTIONS OF THE GENERAL BODY

The General Body of KAA shall meet at least once in a year or more if necessary.

It shall transact such business as the Executive Body may refer to it including the Followings:

- a) to elect two members to the Board of Management from among the ordinary Members; two from Founding Members and one from Special Members or confirm continuance of the sitting members for the next year.
- b) to consider and adopt the Annual Activities Report & Audited financial accounts of the previous period or year.
- c) To transact any other business mentioned in the notice for the General Body or as the President may allow.
- d) To ratify prescribed Rules suggested by the Board of Management.

#### VI. FUNCTIONS OF THE BOARD OF MANAGEMENT:

- a) The business and the affairs of the Association shall be carried on and managed by the Board of Management who shall exercise all such authorities of the Association.
- b) To assign from time to time such functions and duties and delegate such responsibilities as it may deem fit to the President/Secretary.
- c) The Board of Management shall have the authority to formulate amend modify the prescribed rules of the Association with the concurrence of the General Body can be taken Post Facto if necessary.

#### VIII **MEETINGS:**
