The author(s) are required to submit their full paper within 3,000 - 8,000 words including the abstract in a paragraph of maximum 200 words. The author(s) need to provide maximum 5 keywords. Paper should be in MS word, font style -"Times New Roman", font size -title-16 pt, sub-title-14 pt, Body and texts-12 pt and line spacing -1.5, Margins: 1-inch margins on all sides with APPA style of referencing. The author(s) needs to submit the abstract and full paper file in MS Word along with proof of payment details at the time of registration to be made through conference website.

#### Indicate the sub-theme addressed

To facilitate blind review of abstract paper, the cover page should include the title of the paper, author's name(s), email id, contact number, affiliations. The sheet containing the abstract should not contain any identifying details.
