This Statement of Shared Interest is entered into as of September 24, 2022, by and between Kalinga Institute of Social Sciences (KISS) Deemed to be University in Bhubaneswar, India, and Bronx Community College of the City University of New York (CUNY) in New York, New York, U.S.A. to memorialize their mutual intention to promote collaborative academic opportunities between the institutions (Institutions) as set forth herein.

- 1. The purpose of the arrangement described in this Statement of Shared Interest is to memorialize the parties' intent to develop academic and educational cooperation, and to promote relations and mutual understanding, between the Institutions.
- 2. Each Institution undertakes to explore ways in which they might promote and develop academic cooperation through a future agreement within fields that are mutually acceptable and subject to available funds. The Institutions might consider some or all of the following:
 - a) academic collaboration, both on a degree and course level;
 - b) exchange of students and faculty;
 - c) summer schools and faculty led programs;
 - d) joint research programs;
 - e) joint conferences, seminars workshops and exhibitions; and/or
 - f) organization of other academic exchanges agreeable to both universities.
- 3. The terms and conditions of any projects, programs, or other activities that the Institutions wish to implement in furtherance of the purposes of this Statement of Shared Interest shall be subject to negotiation and formal written agreement by the Institutions. Moreover, the terms and conditions of any agreement for such projects, programs, or other activities will be subject to approval by the Chancellor of CUNY in order for such agreement to be binding upon CUNY or Bronx Community College.
- 4. Each party hereto shall respect and, to the extent applicable, abide by the laws and regulations as well as the cultural, religious and social customs of the other party, to the extent that such laws and regulations, and cultural, religious and social customs would not cause either party to violate its own laws and regulations or its own obligations under this Statement of Shared Interest.
- 5. The English version of this Statement of Shared Interest will govern the interpretation of its language.
- 6. This Statement of Shared Interest is not intended to be a legally binding agreement. It confers no rights, imposes no obligations and creates no liability on the part of either party. Nothing herein shall diminish the full autonomy of either Institution in the conduct of its activities with respect to this Statement of Shared Interest.

This Memorandum of Understanding is entered between Kalinga Institute of Social Sciences-Deemed to be University (KISS-DU), India and Daffodil International University (DIU), Bangladesh, in order to promote academic exchange in education and research, hereby conclude an academic cooperation agreement under the headings shown below.

- 1. The academic exchange program includes the following
 - a) Exchange of teaching, non-academic and research staff,
 - b) Exchange of students,
 - c) Organization of joint research projects and symposia,
 - d) Mutual use of academic literature and materials,
 - e) Exchange of publications,
 - f) Other exchanges based on mutual agreement.

- 3. Both universities agree to confirm the details of specific activities, projects and programs identified to be undertaken in accord with this Memorandum.
- 4. This Memorandum is for three years and is automatically renewed. However, each university has the right to discontinue the arrangements through written notice given six months before the date of renewal. The Memorandum may also be terminated at any time by mutual consent of both universities.
- 5. The contents of this Memorandum may be revised at any time by agreement between both universities. The Universities understand that any financial arrangements between the institutions associated with this cooperation will be dealt with separately.

Jagannath University as a govt. financed full pledged public university of Bangladesh is situated in the southern part of the city of Dhaka near the Buriganga. This prestigious educational establishment has a history of about 156 years which started in 1858 when Dhaka Brahma School was founded in 1858 by Dinanath Sen, Prabhaticharan Roy, Anathbandhu Mallik and Brajasundar Kaitra. The name Jagannath school was given by Kishorilal Chowdhury, the Zamindar of Baliadi who took over the school in 1872 and renamed it after his father's name. In 1884, it was raised to a second grade college. Law was one of the first courses introduced in the college. A common management committee administered the school and college until 1887, when the school section was separated to form an independent school named Kishore Jubilee School. PARTNERSHIP AGREEMENT BETWEEN NANHUA UNIVERSITY OF TAIWAN, AND KALINGA INSTITUTE OF SOCIAL SCIENCES OF INDIA

Nanhua University (NHU) in Taiwan, and Kalinga Institute of Social Sciences (KISS) in India hereby agree to foster academic exchange and cooperation between the two organizations.

SCOPE OF COOPERATION

Subject to mutual consent, the areas of cooperation will include any program offered by either organization as felt desirable and feasible on either side and that contributes to fostering and development of the cooperative relationship between the two organizations.

Conditions of the agreement are as follows:

- NHU and KISS agree to work together in selecting and assisting 50 to 100 qualified undergraduate and graduate students to study at Nanhua University for 4 and 2 years, respectively. The study program will start in the Fall 2018 semester. NHU will offer an English taught bachelor program in international business management for the selected students. It should be noted that the courses in the program are open for both the international and local students. KISS is responsible for submitting the necessary application forms, required documents to NHU in time for student visa processing before July 15th 2018.
- NHU will provide 100 percent tuition scholarships for all students (AA type) for the first semester. This tuition waiver scholarship will be renewed each semester. Those whose average GPA scores in the previous semester are ranked within top 30% in the class shall continue to receive 100 percent tuition scholarships in the following semester. The rest then will receive 50 percent tuition scholarships, which will be 850 USD per semester.
- NHU will attempt to assist the students with part-time jobs during the study period. Students can earn up to 400 USD per month doing part-time jobs for 20 hours per week and NHU will assist the students with work visa, and the arrangement of employers. All the students are expected to take the jobs assigned to them being facilitated by the university.
- Students must be capable of covering their airline tickets, visa fees and other expenses during their studies. Approximately, each student should pay 260 USD per month by installment to NHU, and the fees are specified as follows.

The additional allocation/quota can be used from the following semester without expiration date.
- 4. The provisions of the preceding two paragraphs shall not preclude bilateral agreements made between any two (2) participating institutions that hope to exchange more students (Program B: UMAP Bilateral Student Exchange Program).
